Eighth: scholarships (cultural exchange - sub-committee for international students at the Ministry of Foreign Affairs)

At the undergraduate and postgraduate levels

For Academic year 2023-2024

1. The deadline for embassies to send lists of names for scholarship candidates is 1/9/2023.
2. The student must fulfill all the conditions/ requirements for admission to apply for the Egyptian universities in the academic level of the candidate for the scholarship.
3. Scholarship candidates are registered through the scholarship platform in accordance to the rules and regulations organized for that.
4. The student who applying on the "Study in Egypt" platform, at his own expense, is not entitled to transfer the funding agency to his scholarship after completing all procedures, except in exceptional cases after the approval of the competent authority.
5. . Scholarship applicants may be registered until a response is received from the concerned security authorities, and the scholarship is suspended if the authority's objection
6. Allocate 25% of the number of scholarships offered through Cultural Programs and Agreements and the Sub-Committee for international students at the Ministry of Foreign Affairs for nomination to the faculties of the medical sector - engineering - computers and information).
7. For international students who are candidates for scholarships, they are applied to Egyptian universities in regular departments and divisions only, and in case one wishes to enroll in a special study program at the expense of paying the tuition fees and expenses paid by the international student at his own expense for that program.
8. The established scholarships are distributed to all universities throughout the Republic, within the limits of the universities' capacity, in proportion to the number of international students at their own expense.
9. International students whose accepted has been approved by the Presidency of the Republic are not entitled to benefit from scholarships or apply for exemption or reduction of fees and tuition fees prescribed for international students in foreign currency, with the exception of Agency for Development scholarship students at the Ministry of Foreign Affairs.
10. Universities shall contact the Ministry about any students who are nominated on the basis of programs or agreements of the Nile Basin, projects of the European Union or foreign scholarships through joint projects, training courses in Arabic language centers of universities or any short-term training, provided that the university sends to the Central Department of international Students a copy of the agreement concluded or letters of exchange with foreign universities and otherwise in addition to the copies of the students' passports for approval by the competent authority.
11. Scholarship students from African countries (Anglophone and Francophone) are exempted from tuition fees in the language departments of the faculties of Egyptian universities, except for new programs, according to the decision of the Supreme Council of Universities in its session of 19/8/2017.

12. The undergraduate scholarship cannot be converted into a postgraduate scholarship.
13. A postgraduate scholarship cannot be converted into the undergraduate scholarship.
14. Scholarships allocated for the current academic year may not be postponed to the next academic year in accordance with the rules of scholarships for international students.
15. The scholarship is terminated if the student does not use it in the year of nomination and is not replaced by another student
16. In case of a student's failure, the scholarship holder shall bear the tuition fees due for the years of failure
17. Nominate a double number of students for these scholarships (primary and reserve) so that the Central Administration for International Students can select the most suitable of them to distribute to scholarships according to the number determined by the program and the financial conditions.
18. . A committee is established by decision of the Minister of Higher Education and Scientific Research to establish the rules for accepting scholarships.
